LIMITED WARRANTY EFFECTIVE AUGUST 1, 2019

The following Eagle products are covered by a Limited Warranty against defects in materials and workmanship from the date of purchase for length of time as so advertised in current Eagle literature, Eagle website, and or so conveyed by Sales and/or Customer Service.



All Eagle products shown in the Eagle Catalog are covered by a Limited Warranty against defects in materials and workmanship for a period of one year, or as otherwise currently advertised, from date of purchase.



Effective for purchases on or after August 1, 2019, the following Eagle products are covered by a Limited Warranty against defects in materials and workmanship for a period of ten years from date of purchase: Safety Cabinets, Metal Type I Safety Cans, Metal Plunger Cans, Bench Cans and Daub Cans. *

The Warranty is limited to the replacement of Products. Warranty does not apply to any products which have been subject to any misuse, including but not limited to products used with materials (primary liquids) that are not recommended by the manufacturer in instructions furnished with the product or in published product descriptions; products which have been altered in any way by the user or used in a manner inconsistent with their intended use; products which have been subjected to severe treatment (undue pressure against movable parts, exposure to severe weather, dropping, etc.) not reasonably associated with "ordinary" usage.

THESE ARE EAGLE'S ONLY WARRANTIES. EAGLE MAKES NO OTHER EXPRESS WARRANTIES AND HEREBY DISCLAIMS ALL IMPLIED WARRANTIES, INCLUDING, WITHOUT LIMITATION, THE IMPLIED WARRANTIES OF MERCHANTABILITY, NON-INFRINGEMENT AND FITNESS FOR A PARTICULAR PURPOSE. If Distributor notifies Eagle in writing during the warranty period that the products are not in conformity with the warranty, and if Eagle determines that the products are non-conforming, Eagle will, at Eagle's sole option, repair or replace the purchase price thereof, at its sole option, F.O.B. point of manufacture, provided Distributor returns such products to Eagle, freight prepaid. This shall be Distributor's exclusive remedy for Eagle's liability. Any claims not made during the warranty period are deemed waived by Distributor. Eagle's warranty does not attach to Products or parts not manufactured by Eagle. Eagle will pass on to Distributor the warranty, if any, it receives from the manufacturer of such products or part, but only to the extent allowed by such manufacturer. Eagle's aggregate liability to Distributor or anyone claiming through or on behalf of Distributor, with respect to any claim or Loss arising out of or relating to any products or alleged to have resulted from any act or omission of Eagle, whether negligent or otherwise, and whether in tort, contract, or otherwise, shall be limited to an amount not to exceed the price received by Eagle for the portion of the products with respect to which such liability is claimed. Any contract created between the Eagle and Distributor is subject to the specific conditions that (a) Eagle is not obligated to provide insurance or indemnify Distributor, and (b) there are no flow-downs from any person or entity including the federal government that becomes part of the contract.
